Art Portfolio – Submission Agreement

The following guidelines apply to artists submitting their art in order to request assistance through our Artist Outreach program, to promote their art.

hereby enter into the following Agreement:

Agency; Purposes. The Artist appoints the World Artist Network as agent for the works of art (“the Artworks”) submitted under this Agreement, for the purposes of promotion and exhibition. The World Artist Network shall not permit the Artworks to be used for any other purposes without the written consent of the Artist, which could be represented by either mail or e-mail. This agreement applies only to the works submitted under this Agreement and does not make the World Artist Network a general agent for any other works.

Exhibit Submissions. The Artist hereby submits to the World Artist Network, and the World Artist Network accepts those Artworks listed on the Artworks List which is part of this Agreement. Additional Inventory Sheets may be incorporated into this Agreement at such time as both parties agree to the submission of the other works of art. All Inventory Sheets shall be signed by both Arts and Agent.

Authority of Accepted Artist’s Works. Works of art may be accepted for submissions only by or by any person designated by either of them in writing as authorized to accept works of art. The World Artist Network may reject artworks at discretion.

Warranty. The Artist hereby warrants that he/she created and possesses unencumbered title to the Artworks, and that their descriptions are true and accurate.

Pricing Information, dealings. The World Artist Network may need pricing information as part of the presentation to the galleries. The World Artist Network will not directly sell the Artworks unless the Artist provides written authorization for

this to be done during special events. Galleries open to showing the Artist's works will provide the Artist with a separate contract independent of the World Artist Network.

Promotion. The World Artist Network shall use its best efforts to promote the Artworks. The World Artist Network agrees to undertake promotional activities on the Artist's behalf, and the Artist authorizes the World Artist Network to use his/her Artworks during such activities. All Artworks will be clearly represented with the Artist's name.

Representation Fees. The World Artist Network does not charge the Artist for expenses incurred in the submission of works to galleries, and other promotional activities. Donations are accepted to contribute to the continuity of this free program. The World Artist Network may charge a small percentage when selling the Artworks directly during Special Events such as art fairs; the World Artist Network will not proceed without written authorization from the Artist to sell the particular Artworks, and a written consent of the percentage.

Termination of Agreement. Notwithstanding any other provision of this Agreement, this Agreement may be terminated at any time by either the World Artist Network or the Artist, by giving either party a thirty (30) day written notification of termination.

Procedures of Modification. Amendments to this Agreement must be signed by both parties and attached to this Agreement. Both parties must initial any deletions made on this form and any additional provisions written onto it.

Choice of Law. This Agreement shall be governed by the law of the State of Connecticut and the United States of America.
